

The History is presented in a timeline starting with 1897, the arrival of Dr. Mike Hoke who was the first orthopaedic surgeon in Georgia. You will find many of the events to be interesting, educational, and even humorous. Please take time to see how far your state orthopaedic society has come.

HISTORY OF THE GEORGIA ORTHOPAEDIC SOCIETY

2021 is the year GOS will commemorate its 75th anniversary, which will be celebrated at the GOS annual meeting, taking place at the Cloister on Sea Island, GA, October 7 - 10, 2021. The complete history of GOS will be presented in print for the first time in its 75th year history. Listed below is a timeline of key dates and events.

- 1897 The first orthopaedic surgeon in Georgia, Mike Hoke, MD, arrives in Atlanta. He was one of the founders of the Rite Hospital and the first medical director and chief surgeon.
- 1918 J. Hiram Kite, MD began working with Dr. Hoke and succeeded him as chief surgeon in 1928.
- 1919 A new 50 bed Scottish Rite Hospital for Crippled Children was built in Decatur, GA.
- 1927 Future president Franklin D. Roosevelt, who was afflicted with polio, established the Georgia Warm Springs Foundation, and hired Dr. Hoke to be chief surgeon.
- 1932 FDR In his first year as president had the "little white house" built in Warm Springs for his frequent visits with Eleanor.
- 1933 President FDR asked Dr. Charles Edwin Irwin to succeed Dr. Hoke as chief surgeon at Warm Springs. He established a training program which became a popular rotation for Duke and MCG residents. Dr. Irwin was widely published post-polio syndrome and was a skilled hand surgeon. He was the first Georgia orthopaedist to be invited to join the American Society for Surgery of the Hand. Ed and Mabel Irwin became dear friends with FDR and Eleanor.
- 1945 FDR died in the "little white house" while sitting for a portrait. Dr. Irwin gave the eulogy at the Warm Springs memorial service.
- 1945 The first orthopaedic residency program in Georgia was established at MCG in Augusta.
- 1946 Charles "Ed" Irwin founded the Georgia Orthopaedic Society, and the first meeting was held June 19, 1946 at Warm Springs with 12 founding orthopaedic surgeons present.
- 1946 The second Georgia orthopaedic residency program at Emory University was founded. The department chief was Robert P. Kelly, MD, one of the GOS founding members.
- 1948 First annual meeting on the Georgia coast at the King and Prince Hotel. The annual meeting did not leave the coast until 2004 when the Cloister closed for renovations.
- 1949 Dr. Irwin was in an MVA and fractured his femoral neck. No meeting was held that year.
- 1953 First constitution and Bylaws and the annual meeting was held for the first time at the Cloister.
- 1954 The first year an outside guest speaker was invited to the annual meeting.
- 1958 The annual meeting moved to the Cloister permanently and only left temporarily in 2004, 2005, 2007, and 2009. In those years, the meeting was held at the Ritz Lodge at Lake Oconee.
- 1958 Dr. Floyd "Ted" Blivens, MCG Residency program director, began the tradition of a Resident paper competition at each annual meeting. The award for first place was \$50.
- 1958 Dr. Irwin left Warm Springs and was recruited to Georgia Baptist Hospital in Atlanta by Dr. Wood Lovell. He set up practice with Dr. Darius Flinchum to train residents.
- 1959 Dr. Wood Lovell was president of GOS and became medical director of the Scottish Rite in 1965.
- 1960 Dr. Ruth Waring was the first woman to become president of GOS. She and her husband Tom were both orthopaedic surgeons in Savannah and both were founding members of GOS.
- 1961 The first "Silver Bowl" trophy was given to the winner of the Diagnostic Quiz, which later became the Pathology Quiz in 1980.
- 1962 Dr. Jim Funk, founder of Peachtree Orthopaedic Clinic, was president of GOS. In 2005 the annual Distinguished Service Award was established and named after Dr. Funk.
- 1966 The third residency program in Georgia, the Georgia Baptist Medical Center, became a "full residency". It was established by Dr. Richard King and Dr. Wood Lovell.

GOS LOBBYIST REPORT

2021 Legislative Session



The 2021 Legislative session kicked off on January 11, 2021. The first week of the Legislative Session is often filled with ceremonial elections and addresses. While these things happened, the first week was also full of unknowns as legislators, lobbyists, staff, and visitors navigated new protocols designed to protect from COVID-19. Some of these precautions include temperature checks, required testing for legislators, social distancing guidelines, capacity limits, and others.

We expect that education funding and policy, election security, tort reform, budget recommendations, COVID recovery, and improved healthcare will be some of the top issues under the gold dome this year.

Through COVID, we have seen schools struggle with returning students to the classroom. We expect that legislators and agencies will address this and work on policies to assist as well as policies to increase the viability of virtual learning. Election security has been a national headline since November. We have already seen a number of bills dropped addressing voter ID, absentee voting, early voting locations and hours, etc. It is hard to anticipate which measures will cross the finish line, but we do know that legislators are motivated to create a bill that will enhance voter confidence.

In 2020, the legislature passed some key bills for the medical community. These include surprise billing, COVID-19 liability protections and PBM regulation. In 2021, we will continue these successes by working with a strong medical community and strong physician presence in the general assembly. Dr. Ben Watson and Representative Sharon Cooper retained their Chairmanships in the Senate and House Health Committees, respectively. In the Senate, Dr. Dean Burke has been named the new Chairman of Insurance. This is an important position, and it will be beneficial having Dr. Burke at the helm.

Below are some of the issues we will be working on during the 2021 legislative session:

Prior authorization

Physicians are seeking to improve the prior authorization process by establishing greater transparency in drug formularies and streamline the process through standardization and for a 'standard for review and approval' timeline by insurers.

Tort reform

There was a push for tort reform in 2020 but the bill failed to make its way across the aisle. We will take another shot at reform this year. In 2020 there was a coalition of over 50 organizations working on an omnibus bill. In 2021, we will see a more targeted approach aimed at pieces of tort reform including phantom damages and scheduling orders.

COVID-19 liability

This was a big win for the medical community in 2020. The bill enacted immunity for physicians from civil liability when COVID-19 impacted decisions or activities. There has been a bill dropped in 2021 by Representative Trey Kelley that will extend these protections for one year beginning on July 14th. We will be working with the healthcare coalition at the Capitol to ensure this bill passes and that physicians are protected from liability.

Scope of Practice

Every year physicians find themselves in a battle for scope of practice. We have seen this in the past from physician assistants, physical therapists, optometrists, APRNs and others. While we have not seen a scope bill yet, we are prepared to defend the medical license. With five doctors in the general assembly, we are in a good position to educate legislators and remain one of the most successful states in maintaining our scope of practice.

Jim Ninomiya is a practicing orthopaedic surgeon who has spent his entire career in academic medicine. Specializing in adult reconstruction, after over twenty years at the Medical College of Wisconsin in Milwaukee, he is now a professor of orthopaedic surgery at the University of New Mexico in Albuquerque.

He grew up in New York City suburbs and then moved to Woodstock, New York where he went to the University at Albany and studied chemistry and then obtained a master's degree in organic chemistry. After working for IBM, he then attended the University of Vermont for medical school and residency. During this time, he did a two-year NIH sponsored research fellowship in the biochemistry of non-collagenous bone proteins. Following this, he did a fellowship in adult reconstruction and orthopaedic cell biology with Victor Goldberg at Case Western Reserve University in Cleveland.

He has served on a number of NIH study sections and reviews manuscripts for JBJS, the Journal of Orthopaedic Research Arthroplasty, and others. He has served on the program committee for the Orthopaedic Research Society and currently is on the board of the Society of Military Orthopaedic Surgeons, and is a member of the Judiciary Committee for the AAOS.

In his spare time, he enjoys flying aerobatics as well as going cross-country between meetings. He also plays the French horn and was actively involved in many musical ensembles throughout his career. Finally, he also enjoys photography, and hiking and has taken great pleasure in exploring and photographing the beautiful New Mexico landscapes.

He has also served for over twenty years in the Air Force, and most recently was a chief flight surgeon in the Wisconsin Air National Guard at the rank of colonel. He has travelled around the world for humanitarian and educational purposes for the Air Force, and considers this a unique and memorable highlight of his career.

He is most proud of his career in the Air Force, where he believes the camaraderie and sense of purpose are unequalled as a civilian. His presentations will include his experiences as a practicing orthopaedic surgeon, as well as his unique training and experience as a military orthopaedic surgeon.


